Collective consumption of food and drink depends on spatial co-presence. The sharing of space and food plays a crucial role in the establishment and reproduction of social relations and identities. Scholarly treatments of commensal practices and their spatial settings emphasize their use for strategic political ends but also their potential to become routine and unreflected. Contrasts drawn between formal ritual occasions and the mundane commensality of everyday meals often ignore the interwoven references that relate as well as distinguish the extraordinary from the ordinary. Our examinations of these themes will explore commensality as both strategic political action and unreflected embodied practice and address the ways in which spatial, symbolic, and social practices set ritual commensality apart from but also connect it to daily meals.
